The Chairman welcomed all the members and congratulated Shri U.D. Meena, Superintendent on his selection as a Vice President for West Zone unit Gr. 'B' Central Excise Gazetted Officers Association.

Discussion on the points raised during J.C.M.

Fill up the vacancies in the grade of Superintedents, Superintendents & Havaldar.

During the meeting Shri U.D. Meena, Superintendent has requested to take the matter for filling up the vacant post of Superintendent & Inspector cadre as there is an acute shortage of officers in Rajkot Commissionerate. He has submitted that at present 56 only Inspectors are working against Sanctioned Strength of 75, thus 19 posts are vacant.

Similarly, 61 Superintendents are working against Sanctioned Strength of 66 and 5 posts are vacant. He has also submitted that due to shortage of Administrative Officer & Chief Account Officers, Superintendents are looking after the charge of the Administrative Officer and Chief Account Officers, at all 6 Division offices.

Further, Shri Hiren Chaglani, Gr. 'C' Non ministerial Officers Association, Rajkot also requested to take up the matter for filling up the vacant post of Havaldar, as more than 270 posts are vacant in the grade of Havaldar for Rajkot Sector.

The Divisional Deputy/ Assistant Commissioners present in the meeting also requested to take up the matter for filling up the vacant posts in the various grade as they are working under tremendous pressure due to acute shortage of Superintendents and Inspectors.

Reply:- The matter has already been taken up with the Office of the Principal Chief Commissioner, CGST, Ahmedabad Zone, for filling up the vacant post of Superintendent & Inspectors during the meeting with the Principal Chief Commissioner. Further, letters in this regard were also issued to the PCCO, Central GST, Ahmedabad Zone, Ahmedabad for the same.

As regard, filling up the post of Havaldar, now the said posts can be filled up only through Staff Selection Commissioner being now group 'C' post. However, the issue will be taken up again for getting more Officers/ staff for the Commissionerate.
