(B) dated 31.12.2015, **Smt. Sarlaben Sunil Hirabhai Christian (old name : Sarlaben A. Kalasava) is hereby regularized w.e.f 21.07.2020** in the Pay Band-I (5200-20200) of G.P. of Rs. 1800/- (Pre-revised) in the post of Multi Tasking Staff (MTS).

 - (iii) SC/ST/OBC Certificate (in case of candidate belonging to SC/ST/ OBC Category)
 - (iv) Disability Certificate duly signed by the Medical Superintendent/ CMO/ Head Office of the Government Hospital (in case of candidate belonging to Disable Person category).

5. The seniority of Smt. Sarlaben Sunil Hirabhai Christian (CL-TS) on regularization in the grade of MTS will be fixed according to the existing instructions of DoPT.
6. The calculation of service for the purpose of terminal/retirement benefit of Smt. Sarlaben Sunil Hirabhai Christian will be governed as per the DoPT OM No. 51016/2/90 Estt (C) dated 10.09.1993.
7. As per the DoPT OM No. 49014/2/2014-Estt (C) dated 26.02.2016 and 28.07.2016; Smt. Sarlaben Sunil Hirabhai Christian will be covered under Old Pension Scheme.
