**:: TRADE NOTICE NO. 39/2019- GST::**

**Subject: - Instructions regarding E-way Bill Unblocking of E-way Bill facility in CBIC-ACES-GST Application-M/reg**

Kind attention of the Trade is invited to various provisions of the Rule 138 (E) of CGST Rule, 2019. The E-Way Bill system now has a new feature of blocking/unblocking of the taxpayer's GSTIN, as per the Rule. That is, if the GST registered taxpayer has not filed Return 3B for the last two successive months on GST Common portal, then that GSTIN will be blocked for further generation of E-way Bill either as Consignor, Consignee or Transporter.

Once the Return GSTR-3B is filed on the GST Common Portal, the blocked GSTIN will get automatically updated as 'Unblocked' within a day in the E-way Bill system and thereafter the taxpayer can continue with E-Way Bill generation. However, if the status is not updated in E-Way Bill system, then the taxpayer can do it immediately by going to the E-Way Bill portal and clicking on the option **Search->Update Block Status**. Enter the GSTIN, followed by the **CAPTCHA and click on GO**.


Further, the taxpayer intending to restore the E-Way Bill generation facility (EWB-01) has to file the duly filled EWB-05 form (please refer Notification No. 33/2019-Central Tax dated 18.07.2019) manually addressed to the Commissioner, Central GST and Central Excise, Rajkot Commissionerate. The Commissioner after due process will pass the requisite order "Accepting" or "Rejecting" such application manually.
