Unanimously, the following Officers are entrusted with the responsibilities of upkeep/ maintenance of the colonies as tabled under:

- (e) Scrutinizing the housekeeping;
- (f) Keep a vigil on Infrastructure issues like leakage, seepage, electric equipment replacement, etc.;
